A sponsored candidate must submit

the Letter of Sponsorship from the Employer/Authorized person of his/her parent organization. It should be mentioned clearly in the letter that he/she will be granted leave with pay for the complete period of the course.

**N.B.: The OBC-A/OBC-B candidates belong to Non Creamy Layer (NCL) only are eligible for consideration as reserved candidates. OBC-A/OBC-B candidates must produce updated NCL certificate or revalidated OBC-A/OBC-B certificate (issued on/after 01.04.2025) during Counseling /Admission.**

**C. SELECTION PROCEDURE:**

- (i) First preference will be given to the candidates who have valid GATE Score
- (ii) Second preference will be given to the candidates on the basis of PGET-2025 rank
- (iii) Third preference will be given to the candidates who have Company Sponsorship [as mentioned in B(vii)].
- (iv) Fourth preference will be given to the Self-Sponsored candidates who have B.Tech. Pass with CGPA-7.00 and above (CGPA-6.50 and above for SC/ST candidates).

N.B.: Vacancies against reserved categories will be maintained as per govt. rules.
